An Introduction to your School Travel Plan

Warwickshire County Council has actively consulted with parents, the school community, and other agencies when writing the School Travel Plan. A steering group of representatives of staff, students, parents, governors, local organisations, and agencies will work together to shape the plan going forward.

The purpose of this Travel Plan is to identify opportunities for the effective promotion and delivery of safe, and active travel initiatives. This Travel Plan is written by Warwickshire County Councils Road Safety Education Team and does not fulfil all requirements for planning applications. The Travel Plan will complement future Travel Plans required for approval by the Planning Authority as a condition of a planning permission.

Road Safety Education, Current Activities & Training

Every Safe and Active School is supported by an experienced and dedicated Road Safety Officer, who liaises with the Headteacher, teachers and the school office, delivering the road safety education workshops and supporting School Champions to help make a difference and encourage safe and active travel in their school.

Current Active Travel Initiatives

The school is taking part several initiatives to help reduce traffic congestion outside the school entrance and encourage sustainable and safe travel. These are –

Walking (Including Pedestrian Access)

The nearest road to the school, Dordon Ave has a speed limit of 30mph.

The school has 4 pedestrian entrances and 1 for vehicles.

There is a footpath surrounding the school. The footpaths are not shared walk and cycle ways. The footpath is lit.

The nearest crossing point to the school is tactile paving.

Park and Stride Provision

Currently local organisations or the local district authority do not have an agreement in place.

Cycling and Scooting

- There is no dedicated cycle infrastructure near the school.
- There is no pupil cycle storage at the school.
- There is no staff cycle storage at the school.

Bus Travel (School and Public Services)

Birchwood Primary School is served by public bus numbers: 65, 766, 767, 785 and 786.

The nearest bus stop to the school is a bus stop flag. The timetable at the stop did not have a date showing when it was last updated. The bus stop is lit.

Rail Travel

Polesworth Railway Station is approximately 1.6 miles away.

Cars (Including EVs)

Parking around the school mainly takes place in the following streets:

- Dordon Road
- Whitehouse Road

There are no dedicated parking spaces for residents which are managed by a Permit system.

Staff Parking and Car Sharing Schemes

The school has a total of 30 car parking spaces, this includes 1 accessible parking space. It does have a gate and is lit and is not covered by CCTV. There is not space for a school minibus. There are no charging points for electric vehicles.

Currently there is not a Staff only Car Share scheme.

Visitors arriving by car should park on the roads. When parking they should be considerate of our neighbours.

Existing Safety Infrastructure

The following measures are in place to assist in safe travel to the school:

- Tactile paving
- Bollards to prevent parking on junctions by the school
- Dropped kerbs
- Yellow marked Keep Clear markings
- Traffic calming

Survey Headlines

Pupil Hands Up Survey – Mode of Transport to School – Whole School

The below survey data will form a baseline for future analysis of the schools Safe and Active Travel progress.



Pupils at Birchwood Primary were surveyed with the 'hands up' method, whereby students were asked to raise their hands when the teacher read out the mode of transport that they took to school on that day. The graph above highlights that arrival to school by car consistently receives the highest proportion of journeys throughout the week. Walking is the second most favoured method, with scooting cycling and the bus accounting for approximately 1% of all journeys recorded in the week the survey was completed.

The above graph indicates that across all year groups at Birchwood, the main modes of transport that students take are either in a car, or by foot. Notably, within KS1 there were no students who arrive at school by bike, scooter, or public transport. Similarly, there were very few students in KS2 who cycled or scooted to school.

Pupil Hands Up Survey – Mode of Transport – Key Stage Group Breakdown

A breakdown of key stage travel behaviour can be found in the charts below. Due to unforeseen issues with data collection, the below graphs are indicative of only three days within the school week: Wednesday, Thursday and Friday. Year 6 data was unfortunately omitted from the below analysis due to unforeseen complications. Data from key stage 1 (KS1) students highlights a greater proportion of journeys were made without a car to school. With 52% of journeys made by modes other than the car.

Conversely, approximately 45% of key stage 2 (KS2) students arrived at school by methods other than a car. Car journeys to school accounted for a significantly higher proportion of journeys within KS2 than with KS1. Notably, on the days the students were surveyed, 0 students stated that they cycled to school.



Initial Parents Survey – Mode of Transport to School

Parents were initially surveyed in September 2021. The chart below illustrates that the preferred mode of transport for parents is weighted towards either walking or driving a car. The relatively high proportion of parents who indicated that they were already walking to school is a positive signal that modes of sustainable and active travel already exist within the school's cohort of parents.



Parents and guardians were also asked in their initial survey, if they were to travel to school by a different method, what would it be? Walking was the most favourable alternative mode of travel, accounting for 52.5% of the total number of responses.

Of the 67 parents who stated that they typically drive to school, 86% live within 3 miles of the site. Of those parents who typically drive and live within 3 miles of the school, 88% stated that their child either owns a scooter, a bicycle, or both. Thus, removing a potential barrier for active travel.

The cohort of parents who typically drive and live within a 3-mile radius of the school were also asked, what could be done to help you start, continue, or increase walking, scooting or cycling to and from school? A breakdown of responses can be found in the graph below



Staff Survey

With recognition that the response rate (around 24%) was considerably lower than that of the pupil hands-up survey and the initial parent survey, of the ten responses collected from the staff survey, there was an overwhelming proclivity towards driving a car to work. That is, 90% of staff surveyed said that they drove to work. Whilst the other member of staff did not drive themself to school, they did indicate that they received a lift in a car.



The distance staff live from work, broken down...

- The high proportion of staff who drive to work could stem from the distance required for the commute.
- Half of the staff who responded to the survey live over six miles away from the school, thus making modes of transport such as walking, potentially prohibitively time consuming.
- 50% of respondents noted that they live within 5 miles of Birchwood Primary School. The shorter distance that these individuals are required to travel presents an opportunity for a significant number of staff to change their mode of transports to a more sustainable and active alternative.

Monitoring and Reviewing of the School Travel Plan

Birchwood Primary School and the Senior Leadership Team recognises that this plan is a start, and we need to monitor and review our objectives and planned initiatives. We therefore aim to:

- 1) Work closely with Warwickshire County Council to update the STP document annually and ensure that the Active Travel Champion Rhianna Lowe and the working group regularly reports on progress
 - The next survey will be done in September 2022
 - The annual review will take place in the summer term 2023

The School Travel Plan Review will consider pupil travel needs arising from new developments in education and transport provision and the School Travel Plan will be revised as necessary to take account of these.

- 2) Work closely with Warwickshire County Council and participate in the Safe and Active Schools travel programme and ensure that the School Champion and working group regularly report on progress.
- 3) Gain feedback following implementation of any major initiatives. It is encouraged that any successes that have come from this process should be celebrated at a school level. Warwickshire County Council will also share these successes where appropriate.
- 4) Provide parents, pupils, and staff with updates on the school travel plan. It is encouraged that this is added on to the school website.
- 5) The School Travel Plan will be added to the school development / improvement plan.
